Q1. How to submit Application fee and what are the bank details?

A1. Please refer to "Fee Deposit Procedure".

Q2. Who can apply?

A2. Candidate with age limit - Minimum 21 yrs & Maximum 28 yrs. Age relaxation would be granted as per age relaxation rules provided in the advertisement.

Q3. What are the minimum eligibility criteria?

A3. Please refer to Advertisement given on Index page.

Q4. Can data once entered be edited?

A4. Data (Like: Post Applied, Applicant name, Father Name, Mother name, Date of Birth, Mobile No, Email Id) entered while submitting Fees cannot be edited while filling up Application form.

Q5. Is NOC from the existing government job required at the time of Interview /Filling Form?

A5. Yes, the NOC from the existing government job is required at the time of Document verification and not at the time of filling form.

Q6. Are candidates allowed to apply in case of awaited final year Mark sheet /Certificate?

A6. Yes, Candidates whose results are awaited can apply but they should have their result with them before 15/07/2015.

Q7. Are Correspondence courses acceptable?

A7. Correspondence courses from recognized University/ Institute are acceptable. **A) Degree must be completed at the time of submission of application.**

Q8. Can Candidates holding degree (night shift) apply or not?

A8. Yes, candidates holding degree (night shift) can apply if it is a regular degree.

Q9. What is the age relaxation?

A9. Minimum 21 yrs & Maximum 28 yrs. Age relaxation would be granted as per age relaxation rules provided in the advertisement.

Relaxation in upper age limit: (I) SC, ST - 5 years (II) OBC (Non Creamy Layer) - 3 years

Q10. Is it compulsory for the applicant to be a pass out from UGC/AICTE recognized university?

A10. Yes, it is compulsory for the applicant to be a pass out from UGC/AICTE recognized University/Institute.
