HOW TO APPLY

A valid **E-mail id** and **Mobile Number** is mandatory for the submission of your Online Application. **This E-Mail id and Mobile number should be kept active till the declaration of results. Electricity Service Commission (ESC)** will send important information with regards to your application and examination on this registered E-Mail/Mobile number.

Please note that after submission of Application Form the particulars mentioned in the form like **Name of the Candidate, Father's name ,Mother's name , Date of Birth, Mobile Number, Email Id etc. will be considered as Final. Candidate will not be able to edit/delete any fields after submission of form.**
