Candidates may note that the call for Document Verification & Medical Examination of shortlisted candidates for the post of Assistant Manager/(S&T) (E-03) is purely provisional subject to their fulfillment of the eligibility criteria as mentioned in advertisement notice No. LMRC/HR/Rectt./O&M/3/2018 dated 21-2-2018. Candidate must bring with themselves the following documents at the time of document verification/medical examination, without which their medical examination will not be conducted.

- i) Proof of Date of Birth (High School/Matriculation certificate) in original & 3 photocopies
- ii) Proof of having passed Requisite Qualification with Provisional/Diploma or Degree certificates by the date of closing date of online applications i.e on **27.03.2018**. Valid SC of UP in the prescribed format as mentioned in the notification if belongs to reserved community and requiring concession/relaxation.
- iii) SC candidates of UP should also bring domicile certificate of UP.
- iv) The Candidates who have been obtained CGPA/CPI in prescribed qualification as per notification, they should must bring conversion formula from University/Institution for calculation of equivalent percentage of marks.
