The standard of Medical Examination for Maintainer (Electrical) (NE10) is **Non-Executive Bee-One (B-1) category**. The process of medical examination may take up to 3 working days. The candidate must come prepared to join training immediately, as the requirement is very urgent. Candidates may note that the call for Biometric verification, Document Verification & Medical Examination of shortlisted candidates for the post of Maintainer (Electrical) (NE10) is purely provisional subject to their fulfillment of the eligibility criteria as mentioned in advertisement notice No. LMRC/HR/Rectt./O&M/3/2018 dated 21-2-2018. Candidate must bring with themselves the following documents at the time of document verification/medical examination, without which their medical examination will not be conducted.

- i) Proof of Date of Birth (High School/Matriculation certificate) in original & 3 photocopies
- ii) Proof of having passed Requisite Qualification with Provisional/Diploma or Degree certificates by the date of closing date of online applications i.e on **27.03.2018**. Valid SC of UP, ST of UP, OBC of UP certificates, UP Domicile for women of UP, DFF of UP Certificate & ESM certificate in the prescribed format as mentioned in the notification if belongs to reserved community and requiring concession/relaxation.
- iii) SC candidates of UP, OBC candidates of UP should also bring domicile certificate of UP.
- iv) UP Domicile for women of UP, DFF of UP Certificate & ESM certificate should also bring at the time of Document verification & medical test.
- v) **OBC of UP certificates should be current and issued within one year on the closing date of application as mentioned in the notification.**
- vi) The Candidates who have been obtained CGPA/CPI in prescribed qualification as per notification, they must bring conversion formula from University/Institution for calculation of equivalent percentage of marks.

IMPORTANT:-

- i) All candidates are advised to join immediately as extensions will not be possible and consequently further requirement may not be there for their induction.
