Samiti proposes to conduct Limited Departmental Competitive Examination for promotion to the post of Assistant and UDC by inviting ONLINE applications from the eligible candidates. The eligibility conditions as per RRs in vogue are as under:-

- (A) The Computer Based Test referred to above for promotion to the post of Assistant/UDC are the competitive examination and not qualifying in nature. The candidates will be arranged in the order of merit in accordance with the marks secured by them.
- (B) Mere success in the examination confers no right of selection unless the Samiti is satisfied after such verificaitoin as may be considered necessary about the candidates having

regard to his conduct in service, that he is eligible and suitable in all respects for promotion to the post of Assistant/UDC.

- (C) Medium of examination will be bilingual Hindi and English
- (D) A candidate who is or has been declared by the Samiti to be guilty of the following will be summarily rejected:-
 - 1) Obtaining support for his candidates by any means or
 - 2) Impersonating, or
 - 3) Procuring impersonation by any person, or
 - 4) Submitting fabricated document or documents which have been tampered with, or
 - 5) Making statements which are incorrect or false or as suppressing material information, or
 - 6) Resorting to any other irregular or improper means in connection with his/ her candidature for the examination, or
 - 7) Using unfair means during the examination, or
 - 8) Writing irrelevant matter, including obscene language or pornographic matter in the script(s) or
 - 9) Misbehaving in any other manner in the examination hall, or
 - 10) Harassing or doing bodily harm to the staff employed by the Samiti for the conduct of their examination, or
 - 11) Violating any of the instructions issued to candidates along with their Admission Certificates, permitting them to take the examination, or
 - 12) Attempts to commit or as the case may be abetting the Samiti of all or any of the acts specified in the foregoing clause; may, in addition to rendering himself liable to criminal prosecution, be liable:
 - a) To be disqualified by the Samiti from the examination for which he is a candidate; and/or
 - b) To be debarred either permanently or for a specified period:-

- i) by the Samiti from any examination or selection held by them;
- ii) by the Samiti, from any employment under them, and/or
- c) To disciplinary action under the opportunity of making such representation, in writing, as he may wish to make in that behalf, and provided that no penalty under this rule shall be imposed except after:
 - i) giving the candidate an opportunity of making such representation, in writing, as he may wish to make in that behalf, and
 - ii) taking the representation, if any submitted by the candidate within the period allowed to him, into consideration.
- 13) Found ineligible in terms of prescribed requirements of experience of service and qualifications.
- 5. All eligible candidates are requested to be alert and watch Samiti's website for publication of separate intimation for conduct of **ONLINE test**. The detailed instructions and guidelines regarding filling up of online applications and date for conduct of online examination will be intimated therein. It is further to intimate that communication for holding online departmental test will be notified by Samiti in respect of various posts including the post of Assistant/UDC.
