Notes:

- 1) Comments regarding teaching experience:
 - a) The teaching experience in diploma courses or higher in technical colleges / universities (Govt. or private) like Professor, Lecturer, Lab instructor is being considered as relevant experience in the IT field due to the following reasons:
 - i) Based on representations received, a **wider meaning of relevant experience in the IT field** is being taken, since in diploma or higher courses, the individual is expected to be in touch with advanced subjects of computer science and IT fields like operating systems, databases, languages used in software development, computer networks, computer algorithms, data structures, computer graphics, object-oriented programming, etc. In addition to the probable IT lab experience.
 - ii) Documents of all candidates who have cleared the cut-off, apart from the above list of candidates, as provided by the recruiting agency are already being re-examined as per the decision of the recruitment board meeting dt.11/01/2023 to give a fair chance to the candidates.
 - b) The teaching / lab instructor experience in school (upto +2 level) cannot be considered as relevant experience in the IT field since the curriculum taught in school is of very basic nature (like computer and basic programming fundamentals) and does not qualify for relevant experience in the IT field.
 - c) The teaching experience in institutes (except govt. ITIs), coaching centers, etc. cannot be considered as relevant experience in the IT field since the subjects taught and the level of teaching involved is not enough to be considered as relevant experience in the IT field.
- 2) Comments regarding private experience: Earlier the experience in the private unorganized sector / proprietorship was not accepted. However, on review and based on the representations received, a **wider meaning of relevant experience in the private sector in the IT field** is being taken, subject to verification of employment by the recruiting agency using Form 16, salary slips, bank statements, etc.
- 3) Experience of the 6 candidates of CDFO was inadvertently Accepted being in the Teaching / Software development field. While reviewing these cases, this discrepancy came to the notice. Accordingly, the experience of these candidates is now being rejected as the candidates do not have the experience relevant to the field of Computer / Digital forensic.
- 4) The remarks have been given based on the documents provided by the recruiting agency.
- 5) The decisions taken in the Board meetings have been referred to while writing the remarks.
- 6) Verification of employment is to be done by the recruiting agency using Form 16, salary slips, bank statements, etc. as per the decision taken in the board meeting dated 11/01/2023.
