Payment of Fee : (i) For Post Code 01, 02 and 04 the candidates of General and OBC category shall have to pay Rs.750/- (+ Bank charges extra) separately for each Post Code and the candidates belonging to SC/ST category of Uttar Pradesh only shall have to pay Rs.500 /- (+ Bank charges extra) separately for each Post Code.

(ii) For Post Code 03 the candidates of General and OBC category shall have to pay Rs. 500/- (+ Bank charges extra) and the candidates belonging to SC/ST category of Uttar Pradesh only shall have to pay Rs. 300 /- (+ Bank charges extra).

The High Court, Allahabad will hold post code-wise offline Written Examination (on O.M.R. Sheet) followed by Hindi/English Computer Type Test, Hindi/English Shorthand Test and Practical Knowledge of Programming Test wherever applicable.

The information regarding Date, Time and Venue of the Examination/Tests shall be intimated to the candidates through e-admit cards later on.
